**Subject: Opening of admission to Four-Year Undergraduate Programs (FYUGP) for the Academic Session 2025-2026 to 10+2 Biannual passout students.**  
**Reference: Resolutions adopted in the Meeting of Admission Committee held on 26-09-2025**

Sir/Madam,

Owing to the recent declaration of 10+2 Biannual results by JKBOSE, and the decision of the Admission Committee, admissions have been opened to Four-Year Undergraduate Programs (FYUGP) for the Academic Session 2025-2026, for such passouts. Further, the admission shall also be open to all regular students who had not taken admission earlier.

These admissions shall be strictly offered against the leftover seats during the previous admission rounds as per the following schedule:

- The interface for registration on Samarth Portal <http://jkadmission.samarth.ac.in> shall be activated from 29th September 2025, till 4th October 2025, thereby enabling aspirants to apply for admissions in this round. All eligible candidates shall complete the Registration within the stipulated timeline on the Samarth Admission Portal and visit the college for completing the admission formalities.
- Students who have already secured admission in some college in the earlier rounds shall not be eligible to apply in this round. All colleges are advised not to entertain any admission cancellation requests of existing students till the completion of this round.
- For programs where a significant number of seats are vacant, admissions shall be granted on a first-come-first-serve basis.
- **In case the number of seats available in a program are limited, admissions shall be given by preparing merit lists that shall be issued every 3 days after consolidating applications received in the intervening period.**
- Candidates shall be required to deposit admission fee directly with the college as the online payment option will not be available on the Samarth Portal.
- Colleges shall confirm admission of a candidate on the Samarth portal only after receipt of fee.
- **The number of admissions granted shall in no case exceed the approved intake capacity of a program.**
- Colleges shall regularly publish the admission procedure and vacant seat information on their websites/notice boards.
- Colleges shall also keep their Admission Counselling Centers open for assistance to the aspirants.
- Colleges will conduct remedial classes for the newly admitted students as per requirement.
